## A Message from the Executive Director

As we step into a new season, it's the perfect time to pause and reflect on the incredible journey we've embarked on over the past five months since I accepted this role. Each day has brought challenges and opportunities, and I couldn't be prouder of what we've accomplished. Let's take a moment now to celebrate our accomplishments and recognize the har work that has brought us to this point

Over the last five months, we have successfully identified not one, not two, but three potential sites for the village in Montgomery and Delaware Counties along with a funding source. Determined to see our vision fulfilled, we did not rest on our laurels or wallow in disappointment. After a thorough due diligence process we've selected the best location and are now taking steps to perform the site and environmental analysis before working to secure the property.

The property consists of a 13,000 sq ft building sitting on 4 acres of land with loads of potential. The larger building will allow us to provide more services to our residents. The acreage will allow us to house more women experiencing homelessness. While our original imeline had to be revised, we are once again on track and moving forward.
